1. This Agreement is made this 7 day of SEPT, 2012, between the undersigned Purchaser of music ("Purchaser"), and undersigned Artist ("Artist"), through the services of Tropics Entertainment, Inc. ("Agent"). Purchaser engages Artist, and Artist agrees to furnish its musical services for and in consideration of the mutual promises, terms and conditions herein contained. All of the parties agree as follows:

**JOB DESCRIPTION:** WEDDING EVENT

2. The full price agreed upon for this performance is \$11,500.00. All sums shall be paid without deduction of any kind (including taxes) as follows: \$5,750.00 (50% of the full price) as a nonrefundable, initial deposit upon signing this Agreement, and \$5,750.00 (the balance of 50%) paid on or before 7/8/13. Deposit will be made payable to "Tropics Entertainment, Inc." as representative for Artist. Balance will be made payable to Dan Morris. Purchaser or Purchaser's representative represents and warrants that it has the authority and capacity to enter into this Agreement.

3. Purchaser may cancel the engagement before 1/20/13 without liability for the remaining balance of \$5,750.00 but may forfeit the initial deposit. Purchaser shall further be relieved of liability for the remaining balance in the event that the location of the engagement is damaged or unusable, but may forfeit the initial deposit. Agent, in its sole discretion, shall determine what portion, if any, of the initial deposit will be returned to Purchaser. Upon illness, accident, or any unforeseeable condition beyond Artist's control, Artist is entitled to cancel the performance without liability to Artist other than the return of the initial deposit and additional payment made by Purchaser. If staging is set up outdoors, it is agreed and understood that the decision to cancel or to stop performance due to inclement weather shall be made solely by the Artist in its sole discretion. In such event, Purchaser shall remain liable for full payment and is not entitled to any refund. If performance is outdoors, Purchaser agrees that Artist and its equipment will be amply covered from elements and on firm flooring. Once equipment is setup, location cannot be changed. If the performance is cancelled or stopped due to inclement weather, Artist reserves the right to remove its equipment immediately to prevent damage and shall be entitled to leave the venue.

4. The Artist is an independent contractor and shall at all times have complete supervision, direction and control over the services of its personnel on the engagement and expressly reserves the right to control the manner, means and details of the performance of services to fulfill the entertainment requirements. The Artist represents that the amount of performers listed are available to perform the engagement. If a performer should be unavailable, Artist shall arrange for a replacement.

5. This Agreement shall be governed by and construed in accordance with the laws of the State of Florida regardless of its choice of laws provision. Any dispute or action arising out of or related to these terms and conditions will be adjudicated solely in the applicable federal or state courts of competent jurisdiction located in the county of Miami-Dade, Florida. The parties each consent to the jurisdiction and venue of those courts.

6. It is agreed that Agent is providing a service to the Purchaser and Artist, and Agent shall not be liable for any default under this Agreement or any negligent act or omission of the Purchaser or of the Artist arising in any way whatsoever from this Agreement or any related matter.

7. Agreement and Deposit must be returned to Agent, fully executed within 14 calendar days of Agreement date or this Agreement will be considered canceled.
